I understand that: 1) if Plaintiffs are successful, costs expended by the attorneys on my behalf will be deducted from my settlement or judgment before payment to me, 2) that the law firms handling this case may petition the Court for an award of fees and costs to be paid by Defendants, 3) that the fees ultimately retained by the attorneys will be either the amount of fees received from the Defendants as approved by the Court or 1/3 of the total settlement or judgment amount, whichever is greater, 4) fees and costs will be deducted on a pro rata basis from all Plaintiffs' and class members' awards, and 5) if the case is not successful, I will not be obligated to pay any fees or costs.
